October 24, 2022

The regular meeting of the School Board was held Monday, October 24, 2022, 6:00 p.m., at Olive Twp. Elementary School in the Gymnasium with Mr. Phil King, Mr. Dale Groves, Mr. Jason DeMeyer, Mr. Al Williamson and Mrs. Jill Smith present. Dr. Paul White, Superintendent, was also present.

Mr. Phil King, Board President, reviewed guidelines for speaking on agenda items.

INSTRUCTIONAL PRESENTATION

Mrs. Tara Bush, Principal at Olive Twp. Elementary School, gave a presentation on Tier 2 and 3 Academic and Behavior Interventions at Olive Twp. Elementary School. Mrs. Bush explained that Tier 1 is the teaching of essential standards to ALL children then gave a detailed explanation of the two tiers of reteaching to identified students. Identified students are retaught the essential standards using academic and behavior interventions and support so those students can learn and succeed. Mrs. Bush presented examples of individualized plans that identify the goals of each child. Mrs. Bush said that teachers meet consistently to review every child's individualized plan and progress for educational success.

Dr. White congratulated New Prairie's, Miss Lillian Zelasko, who won the Semi-State Cross Country Meet this past weekend. - Dr. White asked that as we prepare for the "Let's Talk Session" to be held after the end of the meeting this evening, please review the published communication sent out to parents last week. He stated that the difficulty in decisions like the one that will be discussed have been weighed very carefully by the Board over many hours, seeking council in the process. Dr. White encouraged everyone to remember that there is a small population of students that this is about and they are kids that are part of our academic processes. Dr. White encouraged respect, restraint, and caution as frustrations and disagreements are shared as there are students behind all of this at the end of the day. Dr. White concluded by stating that we all have to remember we are a public-school system and there are realities and limits that go along with that. No matter what our personal

beliefs are, we are not a private institution, or a religious institution. As a public institution, we may not pick and choose what we do and not do.
